Background 背景

Founded in 1897 by the Hildesheimer Blindenmission, Ebenezer is a charitable agency which provides education, career and boarding services for children with visual impairment, including those with multiple disabilities, and runs a care and attention home for visually impaired elderly.

心光為一慈善服務機構，於1897年由德國喜迪堪援助盲人協會創立。本院服務範圍包括為視障兒童及為視障兼多重障礙兒童提供教育、就業及寄宿服務；此外，本院亦設有護理安老院以照顧視障的老弱人士。

Financial Support 經濟來源

Initial support for Ebenezer came entirely from the Hildesheimer Blindenmission and private donations in Hong Kong and abroad. In 1954, Ebenezer began to receive subvention from the Social Welfare Department and the Education Bureau to maintain existing programmes and further expand its services. Ebenezer is also a member of the Community Chest, and receives support from the Hong Kong Jockey Club and private donations.

機構創立之初，全部資助均來自喜迪堪援助盲人協會及海內外的私人捐款。直到1954年，香港社會福利署及教育局開始資助本院，多年來支持本院維持既有的服務水平及有關的擴展計劃。心光亦為公益金的會員機構，並接受香港賽馬會及私人的捐助。

aiming to provide comprehensive education, rehabilitation, boarding and pre-employment training and services for visually impaired children, including those with multiple disabilities, and visually impaired elderly. Ebenezer also collaborates with other voluntary and Government agencies at local, regional and international levels to enhance services for the visually impaired.





Chairman's Report

With the generous support and contribution of various stakeholders, Ebenezer's services to the visually impaired have been further enhanced this year. Under the leadership of our CEO, devoted Board members, sub-committee members, and the hardworking staff have led the organization to develop its services to a new level.

I would also like to extend our heartfelt gratitude to some of the major donors this year who have laid the foundation for various pioneering projects. We are exceptionally blessed by the Lo Kwee Seong Foundation in approving a 5-year SEE jobs project to provide pre-employment training and employment services for visually impaired youth. With this sponsorship, our young team, for the first time, will work with added manpower without worrying about the financial constraints. The Foundation not only provided us ample financial support but they had also given us invaluable guidance and advice which help us to achieve targets, including employment training, internship, job-employment secured, employment referral and public education. To the Foundation we owe our deep gratitude.

In the year past, there were several special events. The Jockey Club Early Intervention Programme (EIP) was boosted by a renovation of the service centre with upgraded furniture and equipment with a donation from the Hong Kong Jockey Club Charities Trust. The Opening Ceremony cum EIP 20th anniversary was held on 15 March 2019 with the Director of Social Welfare Department, Ms Carol Yip, JP, officiating. In addition, with the Social Welfare Department's subvention, a new service 'Training Subsidy Program' was added to EIP in September 2018; this has significantly reduced the waiting time of the visually impaired children from 16.5 months to 5 months.

We are thankful to the Hong Kong Club Foundation for supporting our Ebenezer Community Support Network for Aged Alumni. This is the second year that Ebenezer has obtained the Hong Kong Club Foundation sponsorship for this worthy and meaningful project. This project aims at providing individual counseling as well as organizing volunteer trainings, smart home and IT

過去一年，心光舉行了幾項特別的活動。在香港賽馬會慈善信託基金的捐助下，賽馬會視障幼兒支援服務中心翻新了中心範圍、家具和設備。賽馬會視障幼兒支援服務中心開幕典禮暨20周年慶典於2019年3月15日舉行，由社會福利署署長葉文娟女士,JP主持。此外，社會福利署在2018年9月向賽馬會視障幼兒支援服務中心增設了一項「培訓資助計劃」的新服務，大大縮減了視障學童輪候服務的時間，由16.5個月縮減至5個月。

我們感激香港會所基金會鼎力支持心光年長校友的社區支援網絡。承蒙香港會所基金會的捐助，心光已是第二年進行這項有意義和價值的項目。這個項目旨在為年長校友提供個別輔導、組織義工培訓、打造智能家居和舉辦資訊科技工作坊，以重拾他們的自信心和重建與社區的聯繫。憑藉這些支援和認可，我們的職員能為有需要的人士提供更適切的服務，並為視障人士帶來希望。

Chief Executive Officer's Report

As a driver of developing the best potentials and crafting a meaningful future for the visually impaired children and youth, caring and professional services are central to each and every Ebenezer unit's strategy. We provide relevant training to our staff adhering to the original vision of Hildesheimer Blindenmission (HBM) in order to nurture experts to grow to meet the needs of our students.

From September 2019 Ebenezer School will, for the first time, operate a senior secondary school curriculum, as an option to those Secondary 3 students who will benefit more from this mainstream program but tailor made to suit their individual differences. This was approved and financed by Education Bureau after discussing and preparing for almost two years. Those students suitable and capable of getting into the ordinary schools will continue to be encouraged and facilitated as early as possible to mainstream education for their benefit and long-term well-being. The Ebenezer School report will highlight this new senior secondary program which is focusing on academic-entrepreneurial mindset-skills approach, with ample opportunities for interactive learning and activities with other schools, the society in general, and career exposure.

Catering for individual differences is significant for child development. All the service units across ages and activities, will be committed to taking up Individualized Education Plans (IEP), which has been, on a trial basis, introduced to some students with remarkable result. This IEP is not just applied to academic subjects, but also includes music, arts, attitude, and independent living skills. We strongly believe that all children, regardless of the challenges they face, if given adequate and professional individual educational plans, will be able to enhance their abilities and potential, and they will develop further. Ebenezer New Hope School program team has mastered this.

In addition to major support from the Lo Kwee Seong Foundation, the Hong Kong Jockey Club Charities Trust and the Hong Kong Club Foundation as detailed in the Chairman's report, we are also very grateful for the sponsorship of other funding partners which helps to enrich the lives of the visually impaired.

With the sponsorship of the Lee Hysan Foundation and distinguished people in the community, the Musical 'SING OUT' was re-run at Hong Kong Cultural Centre in September 2018. This was a local joint school musical which won six awards at the 27th Hong Kong Drama Awards. The story showed the youth how to break through their difficulties and regain their original dream. 80 students from Ebenezer School and Home for the Visually Impaired, Delia Memorial School (Hip Wo), Pui Ching Middle School and HHCKLA Buddhist Ching Kok Secondary School were selected to participate in this local originated musical. They received professional training for nearly six months. They had to strictly observe the rules, get rid of bad habits and cultivate determination to break through the barriers they faced. The potential of the entire cast in this musical was inspirational, and they learnt acceptance and team spirit during the process. This was a precious memory and experience to them. Ebenezer was so fortunate to be one of the two beneficiaries of this 'SING OUT'

musical. We also raised over HK\$2 million from the show.

'Wonder' Charity Film Gala was held in March 2019. Five hundred guests attended and supported this event. Permanent Secretary for Home Affairs, Mrs Cherry Tse Ling Kit-ching, JP; LegCo Members Mr Michael Tien, BBS, JP, and Mr Ip Kin Yuen; Managing Director of Chinese Estates Holdings Ltd, Mrs Lau; and CMA Ladies' Committee Chairperson, Mrs Li Yuen Kam Luen were the officiating guests, and showed great support towards our work in Ebenezer. The donation from this fundraising event will be allocated to musical and other talent developments of our students and alumni.

There was a study trip to Germany in May 2019. Eight staff from different units of Ebenezer visited nearly 10 special schools, NGOs, and social enterprises working with the visually impaired. Their visit to HBM and in-depth exchange with their Board members not only has given them first hand knowledge about Ebenezer's mother organization, but has reignited their passion to serve. Both parties from Hong Kong and Germany have learnt a lot from the professional exchange. They learnt about the latest global trends in the service mode for the visually impaired for future application and development in the local context.

We are conducting a research on the effectiveness of the intervention support to the mild low vision students and the Cerebral Visual Impairment students. We have arranged for professors from the Education Faculty of the University of Hong Kong to provide professional support to the research.

We are committed to applying IT skills to enhance the potential of our students and youth. We support the Hong Kong Blind Union as one of the venue partners of the 'Smart City Walk' App. This App provides audio and text navigation instructions to users in both outdoor and indoor venues and allow visually impaired to walk around more independently. Furthermore, with the sponsorship of Community Partner Foundation Ltd, we are trying out 'OrCam Myeye' to facilitate our students reading and visually impaired youth in their work. By using Artificial Intelligence, it can read texts, recognize objects, identify products and allow the user to access visual information conveyed audibly.

Since this year, the Education Bureau and Social Welfare Department have started enhancing administrative support provided to our facilities repair and maintenance and human resources system. We have employed a Facilities Officer to help coordinate our repair and maintenance works. Our campus has stepped up security by installing electronic access control systems. These are beneficial to our service users, staff and also visitors.

There are internship programs within Ebenezer where interns can gain comprehensive knowledge about workings with Ebenezer. Mr Leung On Kwok Jeffery was one such intern. He is a Year 3 medical student from University College London Medical School and is sighted. He was stationed in different units in Ebenezer for two weeks while job shadowing. He was able to reflect on this opportunity which has helped him to understand the psychological and emotional support needed for visually impaired children and their families. Mr Chan Wing Chun Isaac was another intern in Ebenezer. He became visually impaired with moderate low vision when he was in senior secondary school. His first job was data checking after graduation from the Hong Kong University of Science and Technology. He was then employed as an intern in our Cedar Workshop through CareER. He was funded in his internship with a subsidy by the Lo Kwee Seong Foundation sponsorship. During his internship in Ebenezer, he was grateful that he has broadened his horizons and discovered his capacity and capability in communication.

Our alumna Ms Tsang Tsz Kwan returned from United Kingdom after completing her Masters Degree. Overcoming her total blindness with severe hearing impairment, she never gives up but works very hard in her studies and career planning. She is a very good role model and encouragement for our existing students. Mr Wong Ka Ho is another good example. He is a registered Social Worker. He encountered many difficulties in his study but he got through them with the encouragement of our school social workers and teachers. This is the reason why he chose this discipline of Social Work in the Chinese University of Hong Kong and he has just accomplished his Master's Degree in Family Counselling and hopes to help people in need. Ka Ho has worked in the Senior Citizen Home Safety Association as a team member

of 'Personal Emergency Link Service' for more than 3 years. This is one of the successfully matched cases under the inclusive employment program of Project WORKS.

院長報告

作為推動視障兒童及青年創造有意義的未來和啟發潛能的組織，每個心光部門最為關注的策略莫過於關懷和專業服務。我們承傳德國喜迪堪差會的願景，為團隊提供適切專業培訓，以滿足學生不斷發展的需求。

2019年9月起，心光學校將開辦高中課程，供中三畢業生選擇就讀。我們為中三學生提供切合他們個別學習差異需要及度身訂製的主流課程，讓他們開拓更多的前景。經過接近兩年與教育局的討論和準備，我校獲教育局批准及資助開辦高中課程。對於適合和有能力就讀於普通學校的學生，我們會鼓勵和協助他們儘早入讀普通學校，與他們建立長遠發展的基礎。心光學校報告將匯報新辦的高中課程，其重點是學術及創業之思維技能，提供生涯體驗和充分機會讓學生與其他學校及社會進行互動學習。

照顧個別差異對兒童發展極為重要。服務不同年齡學童和活動範疇的單位將致力執行個別學習計劃(IEP)，此計劃已在試行階段，已向部分學生推行及取得了顯著的成效。個別學習計劃(IEP)不僅適用於學術科目，還包括音樂、藝術、態度和獨立的生活技能。我們堅信，無論學生們面臨任何挑戰，若能給予適當和專業的個別學習計劃，必定能提高他們的能力和潛力，進一步發展潛能。心光期望學校團隊已經掌握了這個重點。

我們要鳴謝羅桂祥基金的鼎力資助，亦衷心感謝香港賽馬會慈善信託基金及香港會所基金會的支持(詳見主席報告)。感激所有合作伙伴的贊助，有助視障人士的生活變得更豐盛。

在利希慎基金及社會知名人士的贊助下，音樂劇《奮青樂與路》在

2018年九月假座香港文化中心重演，這是一部在第27屆香港舞台劇獎勇奪六個獎項的本地聯校音樂劇。這個故事向年輕人展示了如何衝破困難，重拾他們的夢想。80名分別來自心光學校、地利亞修女紀念學校(協和)、香港培正中學及香海正覺蓮社佛教正覺中學的學生獲選參演這部本地原創音樂劇。他們需接受近六個月的專業培訓。培訓期間，必須嚴格遵守規則、改掉壞習慣及鍛鍊他們衝破障礙的決心。這個音樂劇組的潛力是振奮人心的。在過程中，他們學會了接納和團隊精神。對他們來說，這是一段寶貴的回憶和經歷。心光機構有幸成為音樂劇《奮青樂與路》兩名受益者之一，也從這項演出中籌集了超過二百萬港元善款。

慈善電影籌款《奇蹟男孩》於2019年3月舉行，500位嘉賓出席支持這項活動。當天，民政事務局常任秘書長謝凌潔貞女士JP、田北辰議員BBS, JP、葉建源先生、華人置業執行董事劉鑾雄太太、香港中華廠商聯合會婦女委員會主席李阮錦鑾女士，擔任主禮嘉賓，並對心光機構工作表示極大的支持。這項籌款活動所得的善款將分別資助給我校學生及校友，作發展音樂及其他才藝之用。

2019年5月，8名來自心光機構不同單位的教職員到德國進行考察，參觀了近10所特殊學校、非牟利組織和與視障相關的社會企業。他們與喜迪堪差會董事成員進行深入交流，不僅認識創辦心光差會的第一手資料，還燃起我們服務視障人士的熱情。雙方都從專業交流中得著甚多，他們瞭解了服務視障人士方式的全球最新趨勢，以供未來在本地應用及發展之用。

我們正為輕度低視力和大腦性視障學生的介入及支援成效進行研究，並已獲得香港大學教育學院的教授為這項研究提供專業支援。

我們致力應用資訊科技，以提升我校學生和視障青年的潛能。我們參與香港失明人協進會的計劃，為應用程式《逍遙行》作其中一名場地伙伴。此應用程式為使用者提供室外和室內場地的定位導航，導航設有語音及文字指令，讓視障人士能獨立行走。

此外，在社區夥伴基金有限公司的贊助下，我們現正試用OrCam Myeye (人工智能識別眼鏡)，方便學生閱讀及供視障青少年工作。通過人工智能，它可以閱讀文本、辨認物件、識別產品，並讓使用者以語音讀取視覺資訊。

自今年起，教育局及社會福利署逐步加強對維修保養本機構的設施及人力資源的行政支援。我們已聘請一名設施主任，協助統籌維修保養工作。同時，我們在校園安裝了電子門禁管控系統，加強校園保安措施，保障我們的服務使用者、職員及訪客的安全。

心光機構的實習計劃，讓實習生在工作之餘，也獲得完善和全面的知識。梁安國先生是其中一名實習生，他是一名健視的倫敦大學醫學院三年級醫科生。他在心光機構不同單位駐留了兩星期作影子實習，過程中，有助他了解和反思視障學童及其家庭所需的心理和情緒支援。陳穎雋先生是另一名實習生，他在高中時視力受損，屬中度低視力。他在香港科技大學畢業後的第一份工作是數據檢查，後來，他透過CareER的協助，在本機構「松心體驗」當實習生，期間獲羅桂祥基金資助得到生活津貼。在心光機構實習期間，他很感恩能擴闊眼界，也發掘了他在溝通方面的才能。

我校校友曾芷君女士在完成碩士學位後從英國返港。她克服了全失明及嚴重聽障的障礙，永不言敗，在學業及職業生涯規劃加倍努力，是我校學生的典範。黃嘉濠先生是另一個好例子，他是一名註冊社工，在學習期間經歷很多困挫，在學校社工和老師的鼓勵下，他跨過重重艱辛。這正是他選擇入讀香港中文大學社會工作系的原因，他剛剛也取得家庭輔導碩士學位，希望能幫助有需要的人。嘉濠在長者安居協會工作，並當了超過三年「室內平安鐘」的成員，這正是在共融就業計劃下，「有作為計劃」成功配對的個案。

Hon Treasurer's Report

Total general fund income for the year ended 31 March 2019 was HK\$126.8 million, an increase of HK\$13.8 million, or 12.2% more than the previous year (HK\$113.0 million). Expenditure was HK\$126.4 million, an increase of HK\$13.7 million or 12.2% more than previous year (HK\$112.7 million). The surplus for the year was HK\$0.4 million.

Donations and Expenditure

Total income received for the 13 designated funds was HK\$18.8 million, (HK\$3.2 million less than the previous year). This included a major donation from the community project grant of HK\$2.4 million from the Hong Kong Jockey Club Charities Trust for our Early Intervention Programme for Visually Impaired Children. Related expenditure of the various funds for the year amounted to HK\$17.1 million, leaving a balance of HK\$47.4 million in the funds.

We are most thankful to our major funding sources as follows:-

- Recurrent subsidies from the Education Bureau for our two schools were HK\$101.6 million, an increase of HK\$12.4M or 13.9% more than the previous year.
- Subvention from the Social Welfare Department was HK\$18.8 million, an increase of HK\$1.3 million, 7.4% over the previous year.
- Allocation from the Community Chest amounting to HK\$2.2 million, which included a designated donation of HK\$1.0 million for the year.

We would also like to extend our heartfelt thanks to the many other charity trusts/foundations and individuals for their generous contributions during the year.

Expenditure

A breakdown of the main areas of expenditure of our various services is as follows:

Balance Sheet

The balance sheet continues to be stable and healthy, with cash at bank and on hand and time deposits of HK\$72.4 million. The balance on the designated funds is HK\$47.4 million.

Investments

Of the surplus funds which the Board has determined available for investment, approximately 31.8% has been invested in shares, with the balance being placed on time deposit with reputable banks in Hong Kong. The investments are made mainly in blue chip companies listed in Hong Kong and, in general, are held for the long term and for their attractive dividend yields when compared with low interest rates paid on HK dollar deposits.

A portion of the portfolio (approximately 15.7% of the invested portfolio) is trading more actively, with the aim of generating capital gains. The Board has delegated authority to the Finance Committee to make decisions on purchases and sales of this portion of the portfolio. Changes to the larger portfolio require Board approval, on recommendation from the Finance Committee. Updates on the total portfolio are given at each Board meeting.

The portfolio is reviewed monthly by the Finance Committee, but more frequently when there is higher stock exchange activity or other market developments.

Lump Sum Grant (LSG) Reserve under Social Welfare Department
As at 31 March 2019, the LSG Reserve was \$3.0M. The existing reserve level is considered reasonable in order to meet our future and ad hoc needs to fulfill our contractual commitments to staff and to build up a more stable experienced staff team to maintain and strengthen our services.

Provident Fund (PF) Reserve under Social Welfare Department
As at 31 March 2019, the PF Reserve was \$2.8M which can only be used in PF commitments. Some one-off extra MPF employer contributions will be arranged in the year 2019 to encourage long service commitment.

Directors' Report 董事會報告

The directors submit herewith their annual report together with the audited combined financial statements for the year ended 31 March 2019.

Principal place of business

The Ebenezer School and Home for the Visually Impaired Limited (the "Company") is a company incorporated and domiciled in Hong Kong and has its registered office and principal place of business at 131 Pokfulam Road, Hong Kong.

Principal activities and business review

The Company provides educational and boarding facilities for visually impaired children, as well as for mentally and visually impaired children and nursing facilities for elderly visually impaired people. Further discussion and analysis of these activities as required by Schedule 5 to the Companies Ordinance, including a discussion of the principal risks and uncertainties facing the Company and an indication of likely future developments in the Company's business, can be found in the Business Review Report for the Company and its schools set out on page 15 of this Annual Report. This discussion forms part of this Directors' Report.

Surplus for the year and transfer to reserves

The residual surplus for the year was HK\$403,837 (2018: HK\$369,060), which has been transferred to the General Fund reserve; the year-end accumulated deficit has been reduced to HK\$3,253,417 (2018: HK\$3,657,254). A surplus of income over expenditure for the year of HK\$2,184,399 (2018: HK\$11,493,988) was recorded, of which HK\$1,780,562 (2018: HK\$11,124,928) was accumulated from income collected for special purposes, and this amount has been transferred to the reserve for Designated Funds where funds are earmarked for designated projects.

Details of movements in the respective reserves of the Company during the year are set out in the statement of changes in funds and reserves on page 22.

Business Review Report

Fair review of Ebenezer's service

1. The Ebenezer School and Home for the Visually Impaired Limited (Ebenezer) is a non-profit organization founded in 1897 in the Christian faith by Hildesheimer Blindenmission, Germany. It is limited by guarantee and exempted under Section 88 of the Inland Revenue Ordinance.
2. Ebenezer aims to provide quality education, rehabilitation, employment support and residential services for both children with visual impairments and those who are visually impaired with intellectual disability and other disabilities; as well as holistic residential care and nursing facilities for elderly women with visual impairment. For our students, we strive to build comprehensive and multi-faceted education programmes and pave the way for their efficient transition from school to work with the objective of empowering them to lead a dignified life.
3. To achieve our aims, we operate the following programmes targeted at different categories of service users:- Ebenezer School, Ebenezer New Hope School, Ebenezer Child Care Centre, Care & Attention Home, Early Intervention Programme, Project WORKS (Employment Support Service) and Christian Ministry. Further information is given below and elsewhere in this Annual Report.

Principal risks / uncertainties and opportunities facing Ebenezer

4. With support from the Lotteries Fund, major renovation work will be carried out in the coming year for the Care and Attention Home and Child Care Centre. The visually impaired elderly and children will be better served with the upgraded facilities and environment.
5. We were served with a Dangerous Hillside Order on 20 June 2014. With technical and financial support of the Education Bureau and the Social Service Department, remedial work to the site was completed in July 2018 resulting in the Buildings Department revoking the Order on 5 September 2019.
6. Ebenezer is still working on a relocation plan.

Important events affecting Ebenezer since the end of the financial year

7. There have been no important events affecting Ebenezer since the end of the financial year.

Likely future developments

8. With administrative and financing approval from Education Bureau, from September 2019 Ebenezer School will start a senior secondary school curriculum which is a new option for Secondary 3 students who may benefit more from this mainstream program tailor made to suit their individual needs.

9. The development of career life planning for the students will be enhanced via various programmes. Further details of the programmes are given in the Annual Report.
10. The development of IT and Assistive Technology in assisting with the education of visually impaired students is an important area of development in the future. With the help of donors and professionals, we will continue to explore and procure various equipment and software to assist students' learning.

Environmental policies and compliance with laws and regulations

11. We are committed to developing a better tomorrow. We support the development of a sustainable community through green horticulture, management, education and other related programmes at our campus. We also harness planning, energy saving and management initiatives wherever appropriate.
12. The relevant laws and regulations applicable to the various services include compliance with the Education Ordinance and Regulations as well as the Code of Aid for Special Schools, Child Care Services Ordinance and Regulations of Social Welfare Department, Residential Care Homes (Persons with Disabilities) Ordinance and the Companies Ordinance.

Key relationships

13. Being a subvented organization, we work in close partnership with Government departments. In particular; the Education Bureau and the Social Welfare Department which provide 95% of our income for the operation of the relevant services which they subvent, for which we are very grateful.
14. We are mindful of the need to enhance communication with staff through regular staff meetings as well as the use of opinion collection mechanisms through the staff's elected representatives.
15. We work closely with parents of our students, family members of our elderly, and our alumni who are our important partners. We regularly conduct stakeholders' surveys on parents and family members to capture their satisfaction rate.
16. Volunteers and donors are important and very valued supporters of Ebenezer. We appreciate their hard work and donation towards our institution. Regular newsletters, social media and website news postings are communication channels with them. We are particularly grateful to and work hard to maintain a good relationship with our major donors, including the ever helpful Community Chest of Hong Kong and the Hong Kong Jockey Club Charities Trust.

Opinion

Our opinion on the combined financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the combined financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the combined financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Directors' responsibilities for the combined financial statements

The directors are responsible for the preparation of combined financial statements in accordance with the basis of preparation set out in note 2, and for such internal control as the directors determine is necessary to enable the preparation of combined financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the combined financial statements, the directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Company or to cease operations, or have no realistic alternative but to do so.

The directors are responsible for overseeing the Company's financial reporting process.

Auditor's responsibilities

Our responsibility is to express an opinion on these combined financial statements based on our audit and to report our opinion solely to you, as a body, in accordance with Section 405 of the Hong Kong Companies Ordinance, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report.

Our objectives are to obtain reasonable assurance about whether the combined financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with HKSA will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these combined financial statements.



The Ebenezer School and Home for the Visually Impaired Limited Notes to the combined financial statements

For the year ended 31 March 2019

1. Corporate information

The Company is limited by guarantee, such that under the provisions of the Company's Articles of Association, every member shall, in the event of the Company being wound up, contribute such amount as may be required to meet the liabilities of the Company, but not exceeding \$100 each.

The Company is a non-profit organisation and provides educational and boarding facilities for mentally and visually impaired children, as well as nursing facilities for elderly visually impaired people.

2. Basis of preparation

(a) Basis of combination

Previously, the operations of Ebenezer School and Ebenezer New Hope School formed part of the Company. However, pursuant to the requirement of Part IIIB of the Education Ordinance (Cap. 279) and the board's decision on 21 March 2013, it was determined that the Incorporated Management Committees of Ebenezer School and Ebenezer New Hope School were separately incorporated on 31 August 2013 to manage the operations of two schools (the "Reorganisation"). The Company transferred the operations of Ebenezer School and Ebenezer New Hope School and certain of their assets, liabilities, employment contracts and contracts with various suppliers and service providers to the respective Incorporated Management Committees of Ebenezer School and Ebenezer New Hope School on 31 August 2013.

Notwithstanding the above, the Company presents the combined financial statements for the years ended 31 March 2018 and 2019, which comprise the financial statements of the Company, Ebenezer School and Ebenezer New Hope School (together referred to as the "Group") on the basis that all the Group entities are under the common control of the members of the company before and after the Reorganisation. The purpose of the combined financial statements is to enable the members of the Company to evaluate the financial performance and position of the Group.

Intra-group balances, transactions and cash flows are eliminated in full in preparing the combined financial statements.

The combined financial statements have not measured the interests of other sponsoring entities in Ebenezer School and Ebenezer New Hope School as the respective interests may vary.

(b) Statement of compliance

The financial statements of the Company have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRS"), Hong Kong Accounting Standards ("HKAS") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (hereinafter collectively referred to as "Hong Kong Financial Reporting Standards"). The financial statements of Ebenezer School and Ebenezer New Hope School have been prepared in accordance with the accounting requirements of the Code of Aid, relevant letters, circulars and guidelines issued by the Education Bureau and such instructions may be given by the Permanent Secretary for Education.

(c) Disclosure under Section 436 of the Hong Kong Companies Ordinance

These combined financial statements do not constitute the audited financial statements of the Company that have been or to be laid in the Company's annual general meeting or sent to members in the absence of an annual general meeting.

The Company has delivered and will deliver the audited financial statements for the years ended 31 March 2019 and 31 March 2018 to the Companies Registrar as it is required to.

The Company's auditor has reported on the audited financial statements for the years ended 31 March 2019 and 31 March 2018. The auditor's reports were not qualified; and did not contain a statement under either Sections 406(2), 407(2) or 407(3) of the Hong Kong Companies Ordinance.

2. Basis of preparation (cont'd)

(d) Initial application of new and revised HKFRSs

HKFRS 9 replaces HKAS 39 "Financial Instruments: Recognition and Measurement". HKFRS 9 introduces new requirements for classification and measurement of financial assets, including the measurement of impairment for financial assets and hedge accounting. On the other hand, HKFRS 9 incorporates without substantive changes the requirement of HKFRS 39 for recognition and derecognition of financial instruments and the classification and measurement of financial liabilities.

The Company has applied HKFRS 9 retrospectively to items that existed at 1 April 2018 in accordance with the transition requirements. The Company has recognised the cumulative effect of initial application as an adjustment to the opening equity at 1 April 2018. Therefore, comparative information continues to be reported under HKAS 39.

With respect to the Company's financial assets classified as "available-for-sales", the Company has the option to irrevocably designate as FVOCI (non-recycling) on transition to HKFRS 9. The Company elected this designation option for any of the investment held on 1 April 2018 and recognised any fair value changes in respect of these investments in other comprehensive income as they arise. As a result of the changes, the Company's accounting policy, certain reclassifications are therefore not reflected in the statement of financial position as at 31 March 2018, but are recognised in the opening statement of financial position on 1 April 2018. As such, the Company's fair value reserve (recycling) was reclassified to fair value reserve (non-recycling) and the impairment losses of HK\$1,920,126 previously recognised in profit or loss have been reversed from the designated fund to fair value reserve (non-recycling).

On initial application of HKFRS 15, promises in contracts with customers within its scope shall be identified as a performance obligation satisfied over time or a performance obligation satisfied at a point in time. For performance obligations satisfied over time, revenue shall be recognised over time by measuring the progress towards complete satisfaction of that performance obligation. For performance obligations satisfied at a point in time, revenue shall be recognised when the obtains control of the promised good or service. Given the nature of the Company's business, the initial application of HKFRS 15 does not necessitate material changes in the Company's policies, or retrospective adjustments of the comparatives presented in the financial statements.

The initial application of other financial reporting standards does not necessitate material changes in the Company's accounting policies and retrospective adjustments of the comparatives presented in the financial statements.

(e) New and revised HKFRSs in issue but not yet effective

The following HKFRSs in issue at 31 March 2019 have not been applied in the preparation of the Company's financial statements for the year then ended since they were not yet effective for the annual period beginning on 1 April 2018 :-

The Company is required to initially apply HKFRS 16 and Amendments to HKFRS 9 in its annual financial statements beginning on 1 April 2019.

The Company is in the process of making an assessment of what the impact of these amendments and new standards is expected to be in the period of initial application. So far the Company has identified some aspects of the new standards which may have a significant impact on the financial statements. As the Company has not completed its assessment, further impacts may be identified in due course.

3. Significant accounting policies

(a) Measurement basis

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the financial assets at FVOCI (2018: available-for-sale securities) are stated at their fair value as explained in note 3(c).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(b) Fixed assets and depreciation

Fixed assets are stated at cost less accumulated depreciation and impairment losses.

Depreciation is calculated to write off the cost of items of fixed assets, less their estimated residual value, if any, using the straight line method over their estimated useful lives as follows :-

Furniture, fixtures and equipment	5 years
Computer equipment	3 years
Motor vehicles	5 years

Both the useful life of an asset and its residual value, if any, are reviewed annually.

The carrying amounts of fixed assets are reviewed for indications of impairment at the end of each reporting period. An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. The recoverable amount of an asset, or of the cash-generating unit to which it belongs, is the greater of its fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pretax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is reversed if there has been a favourable change in estimates used to determine the recoverable amount.

Gains or losses arising from the retirement or disposal of a fixed asset are determined as the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in profit or loss on the date of retirement or disposal.

(c) Financial assets

Trade receivables that do not contain a significant financial component or for which the Company has applied the practical expedient of not adjusting the effect of a significant financial component are measured at the transaction price determined under HKFRS 15. All the other financial assets are initially recognised at fair value plus transaction costs that are attributable to the acquisition of the financial assets, except in the case of financial assets recorded at fair value through profit or loss. Regular way purchases and sales of financial assets are recognised on the trade date, that is, the date when the Company commits to purchase or sell the asset.

(a) Classification and measurement

(i) Under HKFRS 9

Debt instruments are measured at amortised cost using the effective interest rate method, subject to impairment if the assets are held for the collection of contractual cash flows where those contractual cash flows represent solely payments of principal and interest.

3. Significant accounting policies (cont'd)

(c) Financial assets (cont'd)

(a) Classification and measurement (cont'd)

(i) Under HKFRS 9 (cont'd)

Debt instruments are measured at FVOCI if the assets' contractual cash flows represent solely payments of principal and interest and the assets are held for collection of contractual cash flows and for selling the financial assets. Such financial assets are subsequently measured at fair value with any gains or losses from changes in fair value recognised in other comprehensive income, except for impairment losses and reversal, foreign exchange gains and losses and interest calculated using the effective interest rate method which are recognised in the statement of profit or loss. The cumulative gains or losses previously recognised in other comprehensive income are reclassified from other comprehensive income to the statement of profit or loss when the financial asset is derecognised.

Debt instruments that do not meet the criteria for amortised cost or as financial assets at FVOCI are measured at fair value through profit or loss. Interest income for these financial assets is included in finance income.

Equity investments are measured at fair value through profit or loss unless, on initial recognition, the Company has irrevocably elected to designate such investments that are not held for trading as equity investments at FVOCI. Dividends of such investments are recognised in the statement of profit or loss when the Company's right to receive payment is established. Changes in the fair value of such investments are recognised in other comprehensive income and are never recycled to the statement of profit or loss even when the assets are sold.

(ii) Under HKAS 39

Receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for impairment of doubtful debts

Investments in equity securities, being those held for non-trading purposes, are classified as available-for-sale equity securities. At the end of each reporting period the fair value is remeasured, with any resultant gain or loss being recognised in other comprehensive income and accumulated separately in equity in the fair value reserve.

Dividend income from these investments is recognised in accordance with the policy set out in note 3(h)(e). When these investments are derecognised, the cumulative gain or loss is reclassified from equity to profit or loss.

When there is objective evidence that available-for-sale equity securities are impaired, the cumulative loss that has been recognised in the fair value reserve is reclassified to profit or loss. The amount of the cumulative loss that is recognised in profit or loss is the difference between the acquisition cost (net of any principal repayment and amortisation) and current fair value, less any impairment loss on that asset previously recognised in profit or loss. Objective evidence of impairment includes observable data that comes to the attention of the Company concerning the underlying financial stability of the investee as well as a significant or prolonged decline in the fair value of an investment below its cost.

(b) Impairment

(i) Under HKFRS 9

The Company recognises a loss allowance for expected credit losses (ECLs) on financial assets measured at amortised cost (including accounts receivable, deposits, income receivable, time deposit and cash and cash equivalents).

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Company in accordance with the contract and the cash flows that the Company expects to receive). The maximum period considered when estimating ECLs is the maximum contractual period over which the Company is exposed to credit risk.

3. Significant accounting policies (cont'd)

(c) Financial assets (cont'd)

(b) Impairment (cont'd)

(i) Under HKFRS 9 (cont'd)

In measuring ECLs, the Company takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either (i) 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and (ii) lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

For other financial instruments, the Company recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

At the end of each reporting period, the Company reviews the carrying amounts of other non-current assets to determine whether there is any indication that those assets have suffered an impairment loss. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately, unless the relevant asset is carried at a revalued amount under another standard, in which case the impairment loss is treated as revaluation decrease under that standard.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately, unless the relevant asset is carried at a revalued amount under another standard, in which case the reversal of the impairment loss is treated as revaluation increase under that standard.

(ii) Under HKAS 39

Impairment losses recognised in profit or loss in respect of available-for-sale securities are not reversed through profit or loss. Any subsequent increase in the fair value of such assets is recognised directly in other comprehensive income.

Impairment losses for bad and doubtful debts are recognised when there is objective evidence of impairment and are measured as the difference between the carrying amount of the financial asset and the estimated future cash flows, discounted at the asset's original effective interest rate where the effect of discounting is material. Objective evidence of impairment includes observable data that comes to the attention of the Company about events that have an impact on the asset's estimated future cash flows such as significant financial difficulty of the debtor.

Impairment losses for receivables whose recovery is considered doubtful but not remote are recorded using an allowance account. When the Company is satisfied that recovery is remote, the amount considered irrecoverable is written off against the receivables directly and any amounts held in the allowance account relating to that debt are reversed. Subsequent recoveries of amounts previously charged to the allowance account are reversed against the allowance account. Other changes in the allowance account and subsequent recoveries of amounts previously written off directly are recognised in profit or loss.

(c) Derecognition (under HKFRS 9 and HKAS 39)

Financial assets are derecognised when the rights to receive cash flows from the assets have expired; or where the Company has transferred its contractual rights to receive the cash flows of the financial assets and has transferred substantially all the risks and rewards of ownership; or where control is not retained.

3. Significant accounting policies (cont'd)

(d) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition.

(e) Payables

Payables are initially recognised at fair value and subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

(f) Employee benefits

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(g) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Company has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(h) Revenue recognition

Where a revenue item is attributable to designated funds, the revenue is allocated to the respective funds; all other revenue is allocated to general fund.

Revenue is measured at the fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Company and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follows :-

- (a) Government subsidies are accounted for on an accrual basis. Recurrent grants and earmarked grants for specific purposes spent on capital expenditure are initially recorded as Deferred Capital Fund and recognised as income over the useful lives of the related assets when they are put into use, to the extent of the related depreciation expenses incurred for the period.
- (b) Donations are recognised when the Company becomes entitled to the donations and it is probable that they will be receivable. Donations specifically relating to the acquisition of a capitalisable asset are recognised on a straight line basis over the estimated useful life of the corresponding asset (see note 3(b)).
- (c) Income from boarding fees is recognised on an accrual basis.
- (d) Interest income is recognised as it accrues using the effective interest method.
- (e) Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

(i) Related parties

- (a) A person, or a close member of that person's family, is related to the Company if that person :-
 - (i) has control or joint control over the Company;
 - (ii) has significant influence over the Company; or
 - (iii) is a member of the key management personnel of the Company or the Company's parent.

3. Significant accounting policies (cont'd)

(i) Related parties(cont'd)

- (b) An entity is related to the Company if any of the following conditions applies :-
- (i) The entity and the Company are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
 - (ii) One entity is an associate or a joint venture of the other entity (or an associate or a joint venture of a member of a group of which the other entity is a member).
 - (iii) Both entities are joint ventures of the same third party.
 - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
 - (v) The entity is a post-employment benefit plan for the benefit of employees of either the Company or an entity related to the Company.
 - (vi) The entity is controlled or jointly controlled by a person identified in (a).
 - (vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

(j) Significant judgement

In the process of applying the accounting policies, judgements that can significantly affect the amounts recognised in the combined financial statements are made in determining :-

- (i) whether there is an indication of impairment of assets;
- (ii) the expected manner of recovery of the carrying amount of assets; and
- (iii) the discount rates used to calculate the recoverable amount of assets for the purpose of impairment review.

The Company is exposed to market price risk on the equity and debt investments classified as financial assets at FVOCI (2018: available-for-sale securities) (see note 7).

The Company's investments are listed on the Stock Exchange of Hong Kong and Singapore Exchange. Listed investments held in the investment portfolio have been chosen based on their longer term growth potential and are monitored regularly for performance against expectations.

At 31 March 2019, it is estimated that an increase/decrease of 5% (2018: 5%) in the prices of the investments classified as financial assets at FVOCI/available-for-sale equity securities would have increased/decreased the Company's fair value reserve and total funds and reserves by approximately HK\$1,507,780 (2018: HK\$1,520,552).





Early Intervention Programme 視障幼兒教育支援服務

This year we have begun the second year of the 3-year funding (2017-20) sponsored by the Hong Kong Jockey Club Charities Trust. We advocate for early childhood intervention and whole person development to provide professional and appropriate training for visually impaired children. We integrate visual training and motor skills training and collaborate with other professionals to optimise the overall development of the children.

- In 2018-19, we provided a total of 1331 individual training sessions for 164 visually impaired children, of which 75% were carried out at our centres and 25% were performed at home, special child care centers or hospitals. Over 54% of our children were diagnosed with CVI or showed CVI-related features.
- We were thankful that since August 2017, St. Andrew's Church has made an activity room available for us to provide individual training in a more accessible location. More than 15% of our individual training was conducted at St. Andrew's.
- 'EIP Reunion and Graduation Ceremony' was held in June 2018. A total of 95 guests, including parents, children and volunteers attended the event. There were performances by the children and their parents. We were thankful for Johnson Controls Limited Hong Kong to help again this year to hold activities and game booths for the participants.
- In September 2018, we implemented the 'Priority Case' Policy to provide earlier assessments and training sessions for visually impaired children in the age groups 0-2 and 5-6, in order to shorten the service waiting time and to educate parents about children's visual needs and basic training techniques as earlier as possible.
- To enable our children to transit to Primary One more smoothly, we conducted workshops in April and October 2018 respectively for parents and children who would get promoted to Primary.
- We conducted a talk on cerebral visual impairment (CVI) in October 2018 to help parents understand the characteristics of CVI and the training tools for CVI children. We appreciated the active participation of the parents. In addition, we held the talk 'Writing is Fun' in November 2018 to help parents learn about the difficulties for visually impaired children in writing difficulties and advise them various training techniques.
- From December 2018 to February 2019, we paid visits to some kindergartens to conduct the experiential workshop 'I SEE U, Visually Impaired Children'. We explained the difficulties visually people faced, introduced various accessible facilities in the community, and gave tips on

eye health. Through the experiential activities, we hoped to promote social integration and enhance awareness of healthy visions.

- The renovation project funded by the Jockey Club was completed this year. We were honoured to have Ms Carol Yip, JP, the then-Director of Social Welfare officiate the Opening Ceremony & Open Day of Ebenezer Jockey Club Early Intervention Centre on 15 March 2019 to celebrate the milestone of our centre. Over 100 guests attended the ceremony to take part in the parents' sharing, students' performances and a tour of the centre.

We truly believe in the importance of early intervention. We implemented new service mode this year to reduce the waiting time for children by 50%. After the renovation project, we offered a brand-new environment and equipment for the service users. In the coming years, we will continue to make every effort to provide the best services to the children and parents. On behalf of our team, I would like to express my sincerest thanks to our staff, partners, parents and children for their unreserved support and inspirations.

在新一期香港賽馬會慈善信託基金資助的三年計劃(2017-20) , 本中心已開始進入第二年的服務。在過去一年, 我們秉持及早介入及全人發展理念, 為視障幼兒提供專業適切的訓練; 我們融合視覺和肌能訓練, 並與其他專業協作, 促進幼兒的整體發展。

- 在2018-19年度我們共為164名視障幼兒提供了1331節個別訓練, 當中75%屬中心訓練, 25%為外展訓練服務。在本年度服務的個案中, 超過54%的幼兒患有大腦性視障或表現相關的特徵。
- 我們感謝聖安德烈堂自2017年8月開始借出活動室, 讓我們能夠在尖沙嘴提供個別訓練服務, 為學生及家長有另外一個服務地點的選擇, 減少舟車勞頓的負擔; 在聖安德烈堂進行的個別訓練佔整體個別訓練超過15%。
- 2018年6月, 中心舉辦了「EIP重聚日暨畢業活動」, 當日我們除了有親子的天才表演外, 也很高興再次得到義工團體 (Johnson Controls Limited Hong Kong) 的支持, 協助我們於當日設置了不同的攤位遊戲, 讓我們95名的參加者有不一樣的遊戲體驗。
- 自2018年9月起, 中心為0-2歲及5-6歲2個組別的視障幼兒提供優先服務, 盡早為他們提供評估及訓練, 以縮短幼童輪候服務的時間, 並為家長提供適切支援及教育, 讓他們理解子女的視能特徵及學習需要。
- 為讓中心的幼兒順利銜接小一, 中心於2018年4月及10月舉行視障幼兒升小講座及適應小組, 為升小的幼兒及家長做好升學的準備。
- 中心於2018年10月為輪候服務的家長舉辦大腦性視障 (CVI) 講座。透過講解與片段分享, 讓家長認識CVI的特徵及展示教材, 讓家長初步掌握教具運用的技巧及透過幼兒喜歡的玩具在家中進行視覺訓練。另外, 我們於2018年11月舉辦了「寫字Fun Fun Fun」講座, 讓家長了解視障幼兒的書寫困難及提供訓練方法。
- 中心於2018年12月至2019年2月, 為多間幼稚園舉辦「視障朋友I SEE U」體驗工作坊, 讓幼稚園學生認識視障人士及輔助設施, 傳遞傷健共融的訊息, 並透過活動讓幼兒懂得愛護眼睛及學習保護眼睛的方法。





Ebenezer Child Care Centre 心光幼兒中心

Ebenezer Child Care Centre is a special child care centre with provision of residential service. Our centre is dedicated to providing a high quality learning environment for visually impaired children. We provide tailor-made education and rehabilitation training programmes to maximise the learning potential of our students. The total enrolment as at 31 March 2019 was 35, 5 of which were boarders.

- With the positive outcome in the past 2 years, our centre continued to carry out the Social Adaptation Program in 2018-2019. We aimed to help our children to apply the knowledge and skills they learnt in the classroom to their daily life. According to the ability of the children, our staff carefully planned and created environments which were safe and provided meaningful contexts for them to explore, learn and accumulate experiences outside the centre. We hope that they can get better adapted and engaged more in the community.
- To enhance children's understanding of the teaching themes, we organised visits to Pak Fuk Road Safety Town, Society for the Prevention of Cruelty to Animals (SPCA) Hong Kong, Cyberport Bus Terminus and the Hong Kong Flower Show. We also held experiential activities such as "Simulated Flower Market" at our centre. To consolidate student's language learning, we designed theme-based worksheets, props and flashcards to supplement teaching in Chinese and English lessons. We also provide parent-child activities and encouraged parents to do them at home to learn more about their children's learning progress.
- To enhance parents' knowledge of the developmental stages across childhood and the training skills, we organized talks and seminars on themes such as 'Parent-child Story Reading', 'Improve Children's Pre-verbal Skills', 'Gross Motor Training', 'Pre-braille & Pre-writing Training Tips', and 'Learning Characteristics and Strategy of Visually Impaired Children'. We also invited Ms. Choi Ming Kwan, a clinical psychologist from the Social Welfare Department to deliver introductory Zentangle to parents to help them relieve stress. Besides, various parent-child activities were organised to promote communication between parents and our centre.
- We spare no effort to support the development of professionals in childcare services. We provided internship opportunities for students studying Early Childhood Education at the Hong Kong Baptist University and the University of Hong Kong, Occupational Therapy at the Hong Kong Polytechnic University and a student studying Physiotherapy in the UK.
- To improve the indoor air quality and prevent the spread of diseases, air purifiers have been installed in two classrooms in March 2018, and installation in other classrooms and the dormitory will be carried out soon.

心光幼兒中心是一間兼有住宿服務的視障幼兒中心，因應視障幼兒各種視能情況及發展需要提供優質的學習環境，讓他們能有效地學習及促進各方面的發展，減低日後生活及學習上的障礙。截至2019年3月31為止，本中心共有35位學童，當中包括5位宿生。

- 承前兩年的正面經驗，心光幼兒中心於本年度繼續推展社區適應活動，讓視障幼兒把課堂中所學習到的知識和技巧，應用於日常生活中。同工按幼兒的能力，悉心營造安全和具意義的空間讓幼兒在校外探索學習，體驗不同的社區活動，幫助他們適應和融入社區。
- 為加深幼兒對主題教學的認識，中心舉辦了不同類型的活動，包括參觀北角交通安全城、香港愛護動物協會、數碼港巴士總站及香港花卉展覽，並在中心舉行「模擬行花市」等活動。此外，為鞏固語文學習，本年度中英文科均設計了主題練習紙，並輔以實物、圖卡及字卡進行教學。同時，中心大力鼓勵家長透過親子練習，了解子女的學習進度。
- 為增進家長對幼兒發展階段及訓練技巧的認識，中心舉辦了「親子故事伴讀」、「提升幼兒語前技巧」、「大肌肉訓練」、「點/寫右難度」、「視障學童學習特徵及策略」等多項家長講座及工作坊。另外，中心亦邀請到社署臨床心理學家蔡明坤姑娘向家長分享如何透過「禪繞」放鬆及減壓。此外，中心舉行多個不同類型的親子活動，促進家長與中心的溝通及聯繫。
- 本中心對培訓學前幼兒工作員一向不遺餘力，本年度為香港浸會大學及香港大學教育學院幼兒教育學系、英國物理治療系及香港理工大學職業治療系的學生提供實習機會，冀為培訓業界人才出一分力。
- 為改善室內空氣質素，降低幼兒及職員因細菌傳播引致患病的機會，本中心於2018年3月為兩間課室添置空氣清新機，亦將會陸續在其他課室及宿舍安裝。

Ebenezer School 心光學校

Being the only school offering mainstream curriculum to the visually impaired in Hong Kong, Ebenezer provides a range of services to cater for their needs. As at March 2019, Ebenezer School serves 54 students from Primary 1 to Secondary 3, 37 of whom are boarders. The Boarding Section caters for 53 boarders in total, including 13 mainstream school integrators and 3 special school integrators. The Resource Support Programme (RSP) currently serves 285 visually impaired students studying in 81 mainstream schools in Hong Kong.

- This year was the first year we implemented the 2018-21 School Development Plan. Our major concerns are: revising school curricula for the development of new senior secondary curriculum and improving teaching effectiveness; expanding the school's network for more diverse learning experiences; and fostering a green culture at school.
- We have acquired the approval from the Education Bureau to begin the New Senior Secondary curriculum for visually impaired learners in Hong Kong. We have held meetings with the Bureau and all the stakeholders to gather advice and opinion on the implementation of the NSS curriculum. In addition to the four core subjects, four electives will be offered to cater for students' abilities and learning needs. They are Technology and Living, Health Management and Social Care, Tourism and Hospitality Studies, and Information and Communication Technology.
- A pilot Extended Learning Programme for High-Flyers was introduced to offer learning opportunities of Liberal Studies, Office Assistant Training, Coffee Brewing Training, and Baking and Catering Training. With the integration of training therapies, the course also helped develop students' talents in goalball, music and pottery, preparing them for further study and employment.
- We completed the renovation of the Assistive Technology room and launched the Creative DreamWorks programme with Quality Education Funds and donations from Ms Cho Yuen-Yee. We integrated STEM education across the curriculum. Our students won five awards in the Hong Kong Technology Competition - Smart Car Line Following Robot Competition. Students also explored science in their lives. They studied the impact of global warming and climate change and applied their STEM skills to make useful tools such as mosquito traps, solar heating devices and 'green' wallets.
- We held a cultural study tour to Xi-an, where students visited historical sites to learn about the history and customs of the ancient city. As part of their research, students studied and collected information about the diet, costumes, entertainment and tomb burial practices of the Tang Dynasty.

- 'The Invisible Touch' - Ebenezer's first art exhibition cum charity sale showcasing over a hundred pieces of our students' artwork, was successfully held in the City Hall. The event raised about \$400,000 with the support of the Lions Club. Our students were much encouraged by the love and appreciation of the public.
- In order to improve students' overall ability in playing music, we invited instructors from the Arts with the Disabled Association to teach our students to play the piano, flute, clarinet, trumpet, trombone and percussion instruments. Two students took part in Hong Kong Music Festival and won second and third place in the piano solo competition. Some students also plan to take the Associated Board of the Royal Schools of Music Exams next year. In addition to choir training, we also encourage potential students to receive professional vocal training. We are glad that three students received Lee Bing Vocal Music Development Fund scholarship this year.
- We worked to promote students' habit of regular exercise and strengthen their sports skills. Students participated in different sports events such as Muse Fearless Dragon Charity Run, Go Fun Fearless Dragon Trail Run and Singapore Marathon. S.2 student Chan Pak-Yi took part in three events in Hong Kong Swimming Championships for the Disabled, broke records and won the overall championship.
- The Resource Support Programme (RSP) organised regular seminars and workshops so as to better support students and parents. We invited some high-achieving alumni to teach our integrators study skills, set up scholarships to motivate students and held diversified training programmes to help students integrate into the community.
- We set up an individualised education programme (IEP) for each student, gathering information on students' academia, rehabilitation progress, social skills, other learning experiences (OLE) and career planning, for the establishment and review of short and long-term goals.
- We offered career planning courses for students at different key learning stages and organised the first Ebenezer Alumni Career Mentorship Programme so that our alumni at work can assist the students in career planning. Students also learned workplace skills through simulations, shadowing, financial management workshops, etc.

Ebenezer shall continue to work closely with the Education Bureau, all stakeholders and different parties in the society towards the advancement of education for the visually impaired.

心光學校是全港唯一提供小學至初中主流課程及復康訓練的視障特殊學校，同時支援於主流學校或特殊學校就讀的視障學生。截至2019年3月，小一至中三學生共54名，包37名宿生及17名日讀生。宿舍部宿生共 53名，當中包括13名就讀於主流學校及3名就讀於特殊學校的融合生。本年度「視障學童支援計劃」共支援來自81所中學、小學及特殊學校共285名融合生。學校無論在課程、活動及各種支援工作上，皆引導學生以「克服視障、發展所長」為人生的目標，以德、智、體、群、美、靈六育的教育方向，培養學生積極努力學習，讓學生能建立正確的價值觀與人生態度，長大後能貢獻社會。

- 本學年是「2018-21年度三年學校發展計劃」之第一年，關注事項包括：優化學校課程，配合發展校本新高中，提升學與教效能；加強支援網絡，聯繫協作伙伴，為學生提供多元的學習經歷；以及建立環保校園文化。
- 申辦高中課程經教育局審批後已取得階段性成果，校方定期與局方商討各項行政安排，高中統籌小組積極地向不同持分者介紹高中學制及收集意見。除了四個必修科目外，因應學生的能力及學習需要，開設四個選修科目，包括科技與生活、健康管理與社會關懷、旅遊與款待及資訊與通訊科技。
- 為輕度智障學生開辦「展能延伸先導課程」，包括通識科、辦公室助理、咖啡調配、烘焙和服務助理；體育科重點發展盲人門球；音樂科加入表演元素；視藝科重點發展陶藝；以及將治療訓練元素融合教學，為學生將來升學及就業作好準備。

- 過去一年，本校獲得曹婉怡女士及優質教育基金的資助，完成改建輔助科技室，並開展創意夢工場計劃。學生憑著創意設計自家發明。在推動STEM教育上，著重學生從生活中探究科學知識，學生除了探討全球暖化及氣候變化帶來的環境影響，亦透過使用回收物料設計捕蚊器、太陽能加熱裝置、環保錢包，將科學知識融入生活。本年度全港學生科技大賽中，多名學生投入參與智能車行黑線比賽，並奪得環保創作及比試速度等五個大獎，實行寓遊戲於學習。

- 「從舌尖到筆尖—西安歷史文化深度行」是今年跨境學習的主題，學生通過參觀西安的地標名勝，學習古城的歷史與民生風俗，欣賞中華文化的博大精深。在考察過程中，學生分組搜集有關唐代的飲食、服飾及娛樂、墓葬等資料進行文化探究，反思中西文化薈萃的多元性。
- 《看不到的悸動》心光學生視藝展於大會堂展覽廳順利舉行，展出的作品超過100幅，全是學生課堂上用心創作的成果。是次展覽得到獅子會及公眾人士的鼎力支持，籌得善款約四十萬元。學生發揮潛能，展現「心猶勝目」，在藝術創作領域再次得到大眾的認同與讚許。
- 為提高學生演奏樂器的水平，學校與展能藝術會合作，聘請樂器導師為學生提供鋼琴、長笛、單簧管、小號、長號和敲擊樂訓練，發展學生在公開場合擔任伴奏和合奏的能力。兩位學生分別於香港學校音樂節分級鋼琴獨奏比賽中獲得亞軍及季軍，部分學生亦計劃下年中參加英國皇家音樂學院樂器級別試。校內除了合唱團訓練外，亦推薦具潛質的學生參與聲樂訓練。本年3位學生獲得「李冰聲樂發展基金」，進一步肯定學生努力的成果。
- 學校除了培養學生養成規律運動的習慣，亦經常培訓學生參與運動比賽，包括妙思猛龍慈善跑、猛龍越野賽、新加坡渣打馬拉松等。學生憑著堅毅自信的表現，每次都能完成各項賽事，並屢獲佳績。中二陳柏伊在香港殘疾人游泳錦標賽三個游泳項目中，更打破香港紀錄，獲得全場冠軍。
- 視障學童支援計劃經常舉辦不同主題的教學講座、教具分享、技術轉移、工作坊或研討會，為各類學校和面對不同情境的家長提供適切的支援。此計劃安排成績優秀的學長向外讀生傳授學習及考試心得，並設獎學金鼓勵學生爭取好成績。此外，亦經常舉辦多元化的體驗訓練，凝聚不同學校的視障學生一起學習及參與活動，創造同路人朋友圈。

- 學校為全校學生設立個別學習檔案，從學科、復康、社交溝通/行為情緒、其他學習經歷及生涯規劃等五大範疇去分析學生的強弱項，為學生訂立短期及長期目標，並適時檢討及跟進。
- 除了為不同學階的學生提供生涯規劃課程，本年首次舉辦「心光學校生涯師友計劃」，一班在職的心光年青畢業生化身生涯學長，帶領學弟學妹認識自己的升學就業歷程及工作實況。透過策劃不同類型的職場、影隨工作體驗、理財工作坊等，幫助學生了解自己的職業性向，認識不同企業的實際運作和體驗不同崗位的日常工作，擴闊學生的視野，協助他們及早裝備自己。

心光學校積極與外界聯繫，並加強與教育局、不同持分者及各界緊密協作，致力推動優質視障教育。

Ebenezer New Hope School admitted 10 new students this year, 2 were from Mainland China and 3 were transfer students. The total enrolment as at 31 March 2019 was 61, including 37 boarders and 24 day students. Three students were put on the waiting list for adult services of the Social Welfare Department. 11 students joined the attachment program in the adult service settings.

- Ebenezer New Hope School celebrated its 40th Anniversary on 21 May 2018. Mr. Matthew Cheung Kin Chung, GBM, GBS, JP, Chief Secretary for Administration, and our honorable guests were invited to cut the ribbon for EX-WALL and kick off the education forum. We were grateful to have more than 300 participants, including representatives from Shanghai School for the Blind, Nanjing School for the Blind, Guangzhou School for the Blind, special schools in Macau, special schools and organisations of Hong Kong attending the forum and exhibition to discuss the development of the education for students with visual impairment and multiple disabilities.
- We are grateful for the donation from Drs. Richard Charles & Esther Yewpick Lee Charitable Foundation to support our project 'Shine with Pride', a two-year community inclusion project to support our graduates and their families. During the period from February 2018 to January 2019, the project provided 250 individual training sessions for 10 graduates, 6 parent support group sessions for 72 parents, and 1092 sessions of life and vocational skills training for 14 senior secondary students. Besides, we conducted 10 community education workshops for 5 day activity centres to a total of 136 participants, as well as organised 2 community integration programmes for 64 students from 2 secondary schools.

- With the donation from Keswick Foundation Limited, we continued to implement the fitness project 'EXIT in the Dark'. All the students showed progress in certain fitness areas, and 60% of the them had improvement in their motor function. As a result, students were more energetic in class, able to walk longer during outings, and more independent in community activities. The project organised a number of educational talks for school staff, parents and the public. All PE teachers and houseparents received individual training on the operation of the EX-WALL. We promoted 'EXIT in the Dark' and EX-WALL at our 40th Anniversary Open Day and in the training course coorganised with the Education University of Hong Kong, to about 215 participants.

- We provided occupational therapy sessions for students according to their individual needs, covering training areas such as fine motor skills, feeding, sensory integration, and pre-vocational training. This year, we launched an 'Integrated Sensory Training Program' to provide comprehensive training for students with autistic features and multiple disabilities. The occupational therapists collaborated with the teachers to design activities based on the principles of 'Multi-sensory Learning' and 'Sensory Integration' to stimulate the sensory, motor and cognitive abilities of students. 16 primary 1 and 2 students took part in the program and received two training sessions every week.
- To promote diversified and student-oriented learning, our residential department provided 18 themed sessions for the boarders, including aroma massage, sex education, role play for injection, dental care, information technology, music, hymn singing, living skills, reporter, volunteer training and social manners. Moreover, 69 sessions of indoor and community activities were conducted for a total of 1,502 participants, including 346 volunteers.
- Our students participated in several performances and competitions in sports, music and arts, including:
 - Highly Commended Award in the Modern Dance at the 55th Schools Dance Festival,
 - Merit Awards in Blind or Visually Impaired Instrumental Solo (Piano) and Instrumental Group at the 71st Hong Kong Schools Music Festival,
 - Participated in the 43rd Special Olympic Hong Kong, Regional Athletic Meet I,
 - 4 students gave a music performance at the Spring Reception organised by the Southern District Office, and

今年恩望有10位新生入學，其中2位來自國內，3位是插班生。直至2019年3月31日為止，共有學生61人，其中37位為宿生，24位為日讀生。有3位學生已轉介輪候社會福利署成人服務，另有11位學生獲安排到成人服務機構單位進行實習。

- 2018年5月21日是心光恩望學校40週年校慶的大日子，當天邀請了政務司司長張建宗先生及眾嘉賓為「運動牆」剪綵，以及為教育論壇揭開序幕。超過三百名參加者，包括來自上海市盲童學校、南京市盲人學校、廣州市啟明學校、澳門特殊教育，以及香港的友好學校和機構的代表參與講座和展覽，共同探討視障兼多重障礙學生的教育發展。
- 承蒙利銘澤黃瑤壁慈善基金撥款資助，「傲燃計劃」——一項為期兩年，支援畢業生及家庭的社區共融計劃，由2018年2月至2019年1月期間，為10位畢業生提供250次個別訓練；開辦6節家長支援小組，共有72人次參與；並為14位高中生提供合共1092節的生活及工作技能訓練。此外，計劃亦為5間日間展能中心舉辦10次工作坊，共有136人參加，以及與2間中學合作舉辦2次社區共融活動，並共有64名學生參加。
- 我們於本年度繼續推行由凱瑟克基金資助的體適能訓練計劃——「黑暗的出口」計劃，所有參與者均在體適能方面有進步，而六成參加者的運動機能得到改善。計劃的成果更在日常生活中顯現出來，學生上課時更有活力、戶外步行耐力更持久、參與社區活動時亦更獨立。此外，計劃為職員、家長和公眾人士提供多個教育講座。體育老師和宿舍家長亦接受個別指導，學習自行操作「運動牆」。同時，我們透過40週年校慶開放日和教育大學課程，向大眾推廣此計劃和「運動牆」，共有215人參與。
- 本校職業治療部為學生提供不同種類的治療，包括手肌、進食、感覺統合及職前技能等，以配合學生的個別訓練需要。本年度更開展「感官綜合課」，照顧多重障礙學生的發展需要，亦為有自閉症傾向學生提供適切的訓練。內容由職業治療師及老師一同策劃，以「多感官學習」及「感覺統合」理論為基礎，透過多元化的感官活動，配合仔細調適活動的難易程度，循序漸進地誘發學生感官、肌能及認知的潛能。共有16位小一及小二的學生參與每星期兩節的「感官綜合課」。

- 為促進多元化學習刺激，並配合學生為本的訓練歷程，本校住宿部今年共推行了18個小組，內容包括香薰按摩、性教育、模擬注射疫苗、牙齒保健、資訊科技、音樂、唱詩歌、敲擊樂、家居技能、小记者、義工訓練及社交禮儀等。此外，亦舉行了69節室內及社區活動，參加人數合共1,502人，包括義工346人。
- 本年度，本校學生參與了多個體育、音樂及藝術的表演和比賽，成績令人鼓舞，詳情如下：
 - 第55屆學校舞蹈節，現代舞甲級獎
 - 第71屆校際音樂節，鋼琴獨奏優良獎及樂器組優良獎

Ebenezer Care & Attention Home 心光護理安老院

With the funding support from the Social Welfare Department, we have been providing holistic residential care for visually impaired residents since 1954. We are committed to meeting their health, social and personal needs so that they can enjoy a comfortable homely life.

The total enrolment as at 31 March 2019 was 38. The oldest resident is 109 years old, while 21 residents are 90 years old or above.

The theme of the year was 'Enjoy Life Peacefully', which aimed to:

1. Release the psychological stress of residents with chronic disease;
2. Promote healthy ageing; and
3. Emphasize the importance of healthy diet.

Highlights of the year:

- An Expressive Arts Therapy Workshop was held on 26 May 2018 for a total of 64 residents, relatives and volunteers. Besides, 10 sessions of group counselling were provided to the residents on Saturdays during June and July.
- From December 2018 to March 2019, we invited coaches from the Leisure and Cultural Service Department to provide 'Towel Exercise' sessions for our residents.
- Volunteers of Laughter Yoga held several Laughter Yoga workshops for our residents.
- New menus with healthy soup, dishes and desserts were launched every month to promote healthy diet.
- We invited the Department of Health to provide 12 health talks for the staff and residents, covering a range of topics including 'High Blood Pressure', 'Senile Dementia', 'Knowledge about Osteoarthritis', 'What is Diabetic?', 'Skin Disease', 'Feeding for the elderly', 'Use of strait-jacket', 'Infection Control', 'Chondritis', 'Technique of lifting', 'Knowing about the Dermatophy' and 'Influenza'.
- The 121st Anniversary Celebration was held on 13 October 2018. With over 130 guests and residents attending. Highlights of the celebration included hymn singing, 'Potato Dance' performed by the residents, relatives and staff, as well as the 'Good Neighbour' Recognition Ceremony to present souvenirs to the residents in appreciation of their efforts in doing regular exercise and voluntary work.
- 54 individual volunteers provided a total of 1299 hours of voluntary services, including interest groups, escort services and outing. Besides, 20 voluntary agencies paid visits to the Home and provided 192 hours of voluntary services including festive celebrations, birthday parties and social gatherings.

心光護理安老院自1954年開始接受社會福利署資助，提供24小時住宿服務予女性視障長者，為她們提供醫療、社交及個別照顧。

截止2019年3月31日，全院共有38人。當中有21名院友年屆90歲或以上，最年長院友為109歲的林樂女士。

本院2018/19年度主題為「漫」活人生，主要目的是：

1. 紓緩長期病患院友的情緒困擾，放鬆身心；
2. 舉辦多元化活動，促進院友身心健康；及
3. 提供養生食療，強調健康飲食的重要性。

本年度工作重點如下：

- 2018年5月26日舉行「表達藝術治療」工作坊，共有64位院友、院友親屬及義工參加。此外，本院亦在6月至7月期間的週末為有需要的院友提供10節小組輔導。
- 2018年12月至2019年3月期間，本院邀請康文署教練到院帶領「毛巾操」活動。
- 「大笑瑜伽」團隊定期探訪院友，讓院友開懷大笑，舒筋活絡。
- 加強推廣健康飲食的訊息，並每月推出「養生湯」、「養生燴菜」及「養生甜品」。活動好評如潮，明年會繼續提供健康餐單。
- 香港衛生署到院舉辦健康講座予院友及職員，全年共有12次健康講座，包括「高血壓」、「腦退化症」、「退化性膝關節炎」、「糖尿病」、「皮膚病」、「長者的餵食」、「使用約束物品」、「感染控制」、「肩周炎」、「扶抱技巧」、「認識真菌病」及「流行性感冒」。

- 為提升院舍服務質素，機構非常重視員工培訓，本年度全院員工受訓時數總共172小時。

Christian Ministry 福音事工部

Christian Ministry consists of ministries to Ebenezer School (ES) and ministries to alumni. The former takes care of religious activities of ES and connects with churches, while the latter organises visits, trains up volunteers and provides pastoral care for alumni, as well as helps needy alumni to apply for resources and take charge of alumni fellowship groups and evangelization. These ministries need much support from every sector of the society.

Religious Work within Agency

- Religious Week took place during 8-12 April, featuring various religious activities including lunch Christian radio, hymn sharing, 3 sharing sessions by Enchi Lodge, Ms Maria Lee and Top Ten Regeneration Warrior Ms Kanas Mok, Easter eggs hunt, etc. Everyone actively participated in the activities. We hope to bring students and teachers closer to God through Religious Week, and that more of them will follow Him.

"I do all this for the sake of the gospel, that I may share in its blessings." (1 Corinthians 9:23)

- We invited Uncle Tony to share the story of Joseph with our students using puppets. Students were more interested about the gospel through this fun and interactive activity; some of them even had a chance to play with the puppets. We also invited 開心敬拜隊 to tell the story of Daniel through music. Some alumni performed at the event and all the audience enjoyed their performance.

Christian Ministry to Former Students

- We are serving 581 alumni, including graduates of Ebenezer School and Ebenezer New Hope School and integrated students. We are pleased to announce that two young alumni were baptized in church during Easter. We regret that two elderly alumni passed away peacefully to be with the Lord. Many alumni attended the funeral service to mourn with the deceased's family and bring them encouragement.

Volunteer Training Programme and Smart Home for Senior Workshop

- We were grateful that Hong Kong Club Foundation sponsored our very first Volunteer Training Programme with the aim to equip our volunteers with the necessary knowledge and skills required to cater for the needs of the visually impaired. The participants attended a series of programmes where they acquired orientation and mobility skills as well as learnt about various eye diseases and related assistive devices. They also obtained practical training on communication skills, emotional support as well as gospel sharing. They all actively participated in both workshops and practical training. 39 certificates of appreciation were given to all participating volunteers at the closing ceremony held on 22 June.
- We have held two health talks and smart home automation appliances workshops on 28 August and 24 October respectively. Nearly 30 senior alumni attended and they were utterly enthusiastic about the visit.

Programs with Christian Ministry to Visually Impaired Persons

- Fuk Kwong Fellowship has organised three gatherings, including 'the hymn worship prayer meeting'; with 25 members and staff attending. 'Ark Life Education', the world's first full-scale Ark replica, which enabled the alumni to experience the interactive games and DIY activities, attracted 61 participants. The last one was 'Day trip to Kadoorie Farm and Sai Kung' with 60 participants enjoying themselves to the full.
- Several cell groups in Fuk Kwong Fellowship have organized Christmas Carol Singings during December. All of us were so excited to bring gospel message of Jesus Christ to the community.
- The EEIII graduation ceremony was held on 21 July for the 2 visually impaired students; they were all full of enthusiasm towards spreading the good news to the community.
- Alumni Summer Camp was held in Ebenezer School, with 30 Alumni and visually impaired and 18 volunteers attending.

Annual Events

- The Alumni Christmas Worship Service was held on 8 December, where 94 alumni and volunteers attended. We had included Holy Communion in our Service for the first time. It was also the debut of Miss Cheng being the conductor of 'Cantata Choir' consisting of 18 alumni members. The atmosphere on that occasion was really warm-hearted. The Alumni's Band included the volunteer alumni of Chinese YMCA Secondary school and 8 members performed during the Service.

Ebenezer School Alumni Association (ESAA)

- The first Alumni Day was held on 26 May with over 60 alumni participating. Alumni not only had the chance to visit the History Gallery which was newly open on 21 May, but they also participated actively in the talent show to raise funds for the Alumni Association. The day ended in applause and laughter.
- The AGM cum Alumni Manager Election was held on 15 July and 43 alumni members attended. Mr. Jason Ho was elected as the Alumni Manager for 2018-2020.
- The amendments to the constitution of ESAA were passed at the EGM on 2 March; there were 43 alumni members attending the EGM.
- As at 31 March 2019, ESAA has 248 members, of which 212 members are alumni. ESAA organised trips to Dongguan and Toishan respectively during the year. Besides, we played an active role in motivating alumni to participate in the Ebenezer Charity Walk, which received overwhelming responses.

Looking Ahead

With the continued support from Hong Kong Club Foundation, we shall start our Phase II volunteer training programme. We will connect churches in different districts to collaborate with them for the above programme in order to establish a strong service network for our alumni. We will also start our Youth Alumni Tutors Program to teach our aged alumni to use smartphone, in order to enhance the quality of life of our alumni.

校友福音事工

- 截至2019年3月31日，我們服務581位校友，包括心光學校、外讀生及恩望學校畢業生。
- 今年，有2位年青校友在復活節期間接受洗禮加入教會；另外，有2位年長校友因病離世，不少校友出席了他們的安息禮，向逝者家人表達關懷。

義工培訓計劃及智能家居產品講座

- 承蒙香港會所基金會撥款資助，我們開辦了首屆「義工培訓計劃」，讓義工了解視障教育的基本概念和掌握協助視障人士的專業技巧，使校友們能得到有效的支援。計劃共7課包括定向行走體驗、視障人士輔助儀器使用及認識不同眼疾，情緒關顧、探訪及傳福音技巧工作坊及探訪實習。義工們積極參與課堂及探訪實習，於6月22日的結業禮中，我們共頒發了39張義工證書給完成課程及實習的義工。

- 我們分別在8月28日及10月24日舉辦了2場智能家居及健康講座，接近30位年長校友出席，他們對智能家居產品皆表現得十分雀躍。

與視障人士福音中心（視福）合辦的事工

- 福光團契於本年度共舉辦了三個合組活動，包括「詩歌敬拜祈禱會」，有25位團友及同工出席。「方舟生命教育」，讓團友能夠置身一比一原大的挪亞方舟之中，體驗互動體驗遊戲，DIY工作坊等，共有61人出席。團契旅行「嘉道理農場與西貢一日遊」，共有60人出席，參加者皆十分盡興。小組於12月舉行報佳音，懷著興奮的心情與石硤尾區的街坊分享耶穌誕生的喜樂。
- 視障三福佈道訓練畢業禮於7月21日為2位視障學員舉行，共有23位視障隊員出席。他們對傳福音充滿熱誠，出隊十分投入。
- 校友夏令營在心光校舍進行，共有30位校友及視障朋友及18位義工參加。

年度活動

- 校友聖誕崇拜於12月8日在心光舉行，共有94人出席，首次加入聖餐崇拜，令氣氛十分溫馨。鄭老師首次擔任「樂頌聖詠團」指揮，共有18人獻唱。「校友樂團」包括青年會中學校校友義工共有8人一起獻樂。

心光學校校友會

- 於5月26日舉辦了首個校友日，共有六十多位校友出席。校友不但能參觀於5月21日揭幕的心光歷史館，更非常投入參與為校友會籌款的歌唱表演活動，整個活動在一片歡笑聲中完結。
- 於7月15日舉行週年會員大會暨校友校董選舉，共有43位校友會員出席，選出何家樑校友為2018-2020年度校友校董。
- 於3月2日舉行特別會員大會，通過修改章程，同樣共有43位會員出席。
- 截至2019年3月，校友會共計有248位會員，當中有212位為本校校友。今年舉辦了2次旅行，分別前往東莞及台山。校友會積極推動校友出席「心光傲行」步行籌款，各項活動出席者踴躍。

前瞻

香港會所基金會繼續關心視障長者的需要，並計劃於翌年撥款支持我們開展第二期的「義工培訓計劃」。同時，我們會與多區的教會合辦義工培訓計劃，建立更廣的服務網絡，以便更全面地照顧校友的需要。此外，「年青校友導師教導計劃」會教授長者使用智能手機計劃。期望藉此增強校友社交聯繫。

Project WORKS 「有作為」計畫

Project WORKS is a social innovation project under Ebenezer School & Home for the Visually Impaired. Led by visually impaired (VI) young professionals, we aim at enhancing the employability of the VI young people, improving employers' understanding on the ability of the VI youths, promoting inclusive employment and the development of an inclusive society.

Project WORKS was launched in October 2015. In 2019, we received funds from Lo Kwee Seong Foundation to carry out the "Lo Kwee Seong See Jobs" Project. We have employed 5 people with VI as Project Manager, Project Officer and half-time Assistant Project Officer and Programme Assistants, and provided internships for 8 VI youths. In the year 2018/19, we have the following achievements:

1. Inclusive Employment

This year, we successfully matched 15 jobs, including 4 full-time jobs, 6 part-time jobs and 5 internships. Since our launch, we have successfully matched a total of 44 jobs and paid internships for VI youths, including jobs in customer services, call & care services, research, clerical work, patient enquiry services and events organising.

2. Corporate & Community Partners Engagement

The core of our strategy to promote inclusive employment and job creation for VI youths is to connect and collaborate with different corporates and community partners. This year, we have connected with over 100 corporates and community partners. More than 30 of them are from the business sector and the others are from NGOs, public institutions, government departments, universities and schools. 128 meetings with different partners were held and over 160 significant contacts were made.

3. Capacity Building Programme

We provided diverse professional trainings for VI youths to promote their employability. This year, we organized 11 capacity building programmes., with a total of 63 sessions for 162 VI attendees. The theme of programmes included career seminar, CV writing, interview skills, personal styling, presentation & communication skills training, business writing training, handicraft workshop, event organising and debriefing training, IT & programming, job shadowing etc.

4. Social Enterprise - Cedar Workshop

With the support of the 'Enhancing Employment of People with Disabilities through Small Enterprise' Project, Cedar Workshop was set up in January 2019, offering diverse experiential programmes for corporates, NGOs and universities which include elements of life reflection, team building, sensitivity training, etc. Participants experienced different physical limitations in the programme and learn how to work as a team to overcome adversity. They had a chance to interact directly with our VI youths who are also the facilitators of the programme to learn more about their stories and explore possibilities in life.

5. Our Music Our PRIDE

Our Music Our PRIDE is a music inclusion programme for VI musicians and the general public, which started in December 2016. Our VI musicians dived into the neighborhoods and performed at restaurants, company events and public events to spread the message of social inclusion. We offered residency performances, banquet or ceremony performances, community performances, etc.

Until March 2019, we have cooperated with 3 cafés and restaurants for residency performances and 12 corporate and NGOs for 18 ceremony performances and community performances. 9 VI musicians participated in this project.

6. 'Music X Pride' Professional Development Programme for Visually Impaired Musicians

With the generous support from Lo Kwee Seong Foundation, 'Music X Pride' Professional Development Programme for Visually Impaired Musicians started in May 2018. 14 VI musicians were trained in piano, vocal, drum, guitar and bass guitar. A total of 6 professional music tutors were hired to form a professional music training team for the VI musicians, including 1 VI music tutor.

「有作為」計畫是心光盲人院暨學校轄下的一個就業支援單位，致力增強視障青年的就業能力，增進僱主對視障青年能力的理解，從而促進共融就業和共融社會的發展。

「有作為」計畫於2015年10月開展。在2019年獲得羅桂祥基金的資助，開展「羅桂祥心光導前程」計劃，聘用了5位視障青年為項目經理、項目主任、半職助理項目主任和項目助理，並為8位視障青年提供實習機會。於2018/19年度，本計劃取得了以下進展：

1. 共融就業

本年度，我們成功配對了15個職位，包括4個全職職位、6個兼職職位和5個實習職位。自「有作為」計畫開展以來，共為視障青年配對了44個工作和實習機會。成功配對的工作性質包括：客戶服務、電話關懷服務、研究工作、文書工作、病人查詢服務、活動策劃等。

2. 企業及社區合作夥伴的參與

與不同的企業及社區夥伴連繫和合作是我們促進共融就業和創造就業機會的策略核心。本年，我們連繫了100多間企業及社區夥伴，當中30多間是商業公司，其餘為非政府組織、公共機構、政府部門、大學和學校。我們與不同合作夥伴舉行了128次會議，並進行了160多次重要聯繫。

3. 職業培訓

為了提高視障青年的就業能力，我們提供了多種職業培訓。本年度，我們舉辦了11項職業培訓，共有63節和162名參與人次。培訓內容包括就業講座、履歷撰寫及面試技巧培訓、個人職業形象指導、演講和溝通技巧培訓、商務寫作培訓、手工藝工作坊、活動策劃及解說技巧訓練、IT應用訓練和工作影子實習等。

4. 社會企業-「松心體驗」

在社會福利署創業展才能計畫的支持下，Cedar Workshop於2019年1月成立，為企業、非政府組織和學校提供多種不同的體驗工作坊，包括：團隊建設工作坊、共融職場訓練、視障體驗及生命故事分享等。參加者在工作坊中體驗不同的身體限制，並學習如何透過團隊合作克服逆境。參加者在工作坊中可與我們的視障青年直接互動及交流，以瞭解他們的故事並探索生命的可能性。

5. 《樂與傲》音樂共融計畫

《樂與傲》是一項促進視障音樂人和社會大眾共融的音樂計畫，於2016年12月開展。我們的視障音樂人走進社區，在餐廳、咖啡廳、企業和社區活動中進行音樂表演，宣揚社會共融訊息。音樂表演模式包括：駐場音樂表演、宴會或典禮表演和社區表演等。

直至2019年3月，我們與3間咖啡廳和餐廳合作，於餐廳內進行定期音樂表演，並與12間企業和非政府組織合作，舉行了18場典禮和社區表演。共有9名視障音樂人參與此計畫。

6. 《樂與傲》視障音樂人專業培訓計畫

在羅桂祥基金的慷慨支持下，《樂與傲》視障音樂人專業培訓計劃於2018年5月展開，共14名視障青年接受了鋼琴、聲樂、鼓、結他和低音結他培訓。計畫共聘請了6名專業音樂導師，其中包括1名視障音樂導師。
